

# **VODAFONE 24 MONTH QANTAS BUSINESS RED PLANS** **and BUSINESS FLEX PLANS – TERMS AND CONDITIONS** **- ACQUIRE POINTS**

1. New or upgrading business customers who sign up to one of the eligible 24 month Vodafone plans detailed in the table below (**Eligible Plan**) are eligible to receive a one-off allowance of Acquire Points (subject to compliance with these Terms and Conditions). The total Acquire Points a business can earn per Eligible Plan is also detailed below (**Eligible Points**).

1. These Terms and Conditions operate in conjunction with the Business Terms and Conditions which are available at [Vodafone.com.au/terms](http://Vodafone.com.au/terms). The Business Terms and Conditions contain important details about your Eligible Plan, while these Terms and Conditions relate more specifically to the Aquire Points offered with those plans. By agreeing to sign up to an Eligible Plan, you agree to both sets of Terms and Conditions.
2. A business must be a current member of the Aquire program and must supply their ABN to Vodafone to be eligible to earn Aquire Points through the purchase of an Eligible Plan. If a business is not a current member of the Aquire program, but otherwise eligible to join, they can join for no additional cost at [Vodafone.com.au/qantas](http://Vodafone.com.au/qantas). (A join fee of \$89.50 usually applies).
3. The Aquire membership account and Vodafone account must use the same ABN in order to earn Eligible Points.
4. Eligible Plans are only available to approved business customers with an ABN. Individuals cannot purchase Eligible Plans and do not qualify for Eligible Points. For information regarding Vodafone/Qantas consumer products go to <http://www.vodafone.com.au/personal/plans/qantas>.
5. Membership of the Aquire Loyalty Program and the earning and redemption of Eligible Points earned through the Eligible Plan are subject to the Aquire Loyalty Program Terms and Conditions which can be found at [www.aquire.com.au](http://www.aquire.com.au). These terms are subject to change from time to time.
6. To earn Eligible Points, simply complete the online form either at the time of purchase of the Eligible Plan or within 60 days of sign up via [vodafone.com.au/qantas](http://vodafone.com.au/qantas). As part of completing this form, the business must provide Vodafone with their ABN. If the business fails to submit a valid claim form within 60 days of sign up, any Eligible Points that the business otherwise would have been entitled to will be forfeited. By virtue of submitting the form, the person submitting the form acknowledges on behalf of the business and agrees that all information collected via the form will be shared with Qantas for the purposes of crediting Aquire Points and may be used in accordance with the Aquire Loyalty Program Terms and Conditions which can be found at [www.aquire.com.au](http://www.aquire.com.au).
7. If you sign up to a Qantas Business Red SIM Only or a Qantas Business Red SIM Only Shared Plan, you are not eligible to transfer or upgrade to a Qantas Business Red Plan or Qantas Business Red Shared Plan.

8. If the business moves to a more expensive Eligible Plan during the minimum commitment period, that business will not be eligible to receive any further Aquire Points – and will only be entitled to the amount of Eligible Points that correspond to the original Eligible Plan's Eligible Points entitlement.
9. Eligible Points are earned once only during the term of the Eligible Plan and ARE NOT a monthly inclusion.
10. Allow up to 30 days for Eligible Points to be credited to the business' Aquire account.

12. Vodafone recommends business' and their nominated Qantas Points recipients consult their accountant or tax adviser to ensure they understand possible tax implications (including example fringe benefits tax), if any, related to their earning and use of Aquire Points.
13. A business will only be eligible for the Online Bonus Eligible Points if they sign up to an Eligible Plan online via [vodafone.com.au](http://vodafone.com.au).
14. If a business moves to a Vodafone plan which is not an Eligible Plan prior to claiming Eligible Points, any entitlement to receive Eligible Points will be forfeited.
15. If a business elects to cancel their Eligible Plan pursuant to a claim under the Vodafone Network Guarantee, they will not be eligible to receive any Eligible Points.
16. If a business elects to Rate Plan Change to an Eligible Plan part way through their existing plan commitment period, they will not qualify for any Eligible Points.
17. If a business purchases an Eligible Plan which is a Qantas Business Red Shared Plan or a Qantas Business Red SIM Only Shared Plan, the Eligible Points will be credited to the Vodafone Account Holder only. Eligible Points cannot be shared between sharing plans or transferred through Vodafone to any other user or any other Aquire member.
18. Eligible Points are not exchangeable, transferrable or redeemable for cash.
