1. What Terms and Conditions Apply to my Vodafone Prepaid Product?

- (a) This document sets out the Terms and Conditions that apply to specific Vodafone contracts and products (collectively, the **Products**).
- (b) The terms and conditions that will apply to your Product or Products are:
 - (i) all the terms and conditions provided to you when you agree to purchase a Product, including all the terms and conditions contained in this document; and
 - (ii) all the terms and conditions contained in the Vodafone Standard Form of Agreement (**SFOA**), which is available at vodafone.com.au(collectively, the "**Terms**").
- (c) You accept the Terms when:
 - (i) you purchase a Product or are provided with a Prepaid Pack and activate either of these by:
 - i. calling us on 1555 from your Vodafone mobile; or
 - ii. Accessing our website at www.vodafone.com.au to register/activate; OR
 - (ii) you activate a Product switching from a Vodafone Postpaid Product to a Vodafone Prepaid Product.
- (d) Your contract commences on your acceptance of the Terms, however, any credit expiry period does not start until you have recharged your Prepaid account.
- (e) The Terms may be changed by Vodafone from time to time. Vodafone will comply with relevant laws, regulations and industry codes if it makes any such changes.
- (f) Vodafone's Fair Use Policy applies to any unreasonable use of Products. This includes use of any "unlimited" or "infinite" offerings. See www.vodafone.com.au/aboutvodafone/legal/fairusepolicy
- (g) For more information, call Vodafone on:
 - (i) 1300 650 410 from any phone within Australia;
 - (ii) 1555 for free from your Vodafone mobile when in Australia; or

2. Important Things You Need to Know

Availability

- (a) The Products are for personal use only, and are not available to medium to large business/corporate and commercial customers. Medium to large business/corporate and commercial customers should contact Vodafone for information about Vodafone's business products.
- (b) The Products are available to eligible and approved customers.
- (c) Unless otherwise stated, only one Vodafone Prepaid Product can be used per connection to our network.
- (d) Mobile devices may be locked to our network. A fee may apply to unlock.

- (e) Only services specified in section 11, "Vodafone Rates: What is payable from my Vodafone Prepaid Credit" can be accessed using Vodafone Prepaid Products.

Factors affecting availability and performance

- (a) Network coverage and many other factors may affect the availability and performance of certain Products, services and functions.
- (b) Certain Products, services and functions are only available if used in conjunction with a compatible mobile device and if in a compatible coverage area. Not all mobile devices are compatible with our network.
- (c) The Terms contain details regarding device compatibility, network capability and availability relating to the "Vodafone" network. However, notwithstanding anything else in our contract with you, in addition to the "Vodafone" networks operated by, for or on behalf of Vodafone Network Pty Limited and Vodafone Australia Pty Limited, we may provide services to you using any telecommunications network we consider appropriate and that network will constitute "our network" for the purpose of the Terms. For more information about "our" network, see <http://www.vodafone.com.au/personal/services/coverage/>.
- (d) All Vodafone services are subject to device capabilities & network limitations & availability. A compatible 3G+ device is required to access Vodafone 3G+ services. Vodafone 3G+ only available in selected metropolitan areas. Outside of Vodafone 3G+ coverage areas, Broadband Speeds can be achieved in Vodafone 3G coverage areas. Vodafone 3G+ and 3G services include but are not limited to mobile broadband, internet, email, apps, downloading, video streaming and video calling. A compatible 3G device is required to access 3G services. Vodafone 3G works on three different 3G network zones: U2100MHz, U850MHz and U900MHz. You can reach Broadband Speeds within these areas when you have a handset which is compatible to that particular zone/s.. Broadband Speeds not available in any 2G area. Actual speed achieved varies depending on factors such as device capabilities, location & network congestion.
- (e) Vodafone 4G is available in and around selected Australian cities. Go to vodafone.com.au/coverage to see if you are covered.
- (f) See vodafone.com.au/coverage for coverage details. You agree to refer to www.vodafone.com.au/coverage for coverage details and vodafone.com.au/devicefrequency for details of devices and their frequencies before purchase, so that you can confirm that for your intended use of the services, your address/es are located in the appropriate Vodafone coverage areas and that the device you wish to select is compatible with the Vodafone coverage area where your address/es are located.

Data services, including Pay As You Go Mobile Internet

- (a) For data Products, a data session:
- (i) **starts** when you begin internet activity, either directly or indirectly* on your mobile device; and
 - (ii) **ends** when your data connection is lost. This will happen when:
 - You turn your mobile device off, turn your data connection off, switch to flight mode or when you lose network reception; or
 - Your mobile device has not sent or received data for a period of time .

*Direct internet activity is when you prompt your mobile device to send or receive data from the internet. For example, when you send an email. Indirect internet activity is when your mobile device or mobile applications are set up to send or receive data from the internet on your behalf. Examples include (but are not limited to): Email notifications via Gmail, notification of Tweets or Facebook posts which mention you and software or whether updates.

- (b) A minimum balance is required to start a data session.
- (c) When using data Products, some internet services, including web sites and email, may not be accessible.
- (d) Subject to your rights under the *Competition and Consumer Act 2010* or other relevant legislation (including the *Australian Consumer Law*), Vodafone does not make any warranty regarding any software or data provided or available to you in connection with data services, including with respect to how that software or data operates on your device or interacts with applications.
- (e) Unless otherwise stated, data usage is measured as the combination of both data you send (upload) and receive (download).

Rates and types of credit

- (a) Unless otherwise stated call usage is charged in blocks of 60 seconds. Usage is rounded up to the end of the current block.
- (b) Each call made by a customer may last for a maximum duration of 2 hours, provided the customer has sufficient credit and privileges to make the call.
- (c) Each call and data charge is rounded up to the nearest cent and includes GST (where GST applies)
- (d) Unless otherwise stated, data usage is billed in per kilobyte (kB) blocks.
- (e) Details of the rates and charges which apply to the Products are contained in the Terms.
- (f) All Vodafone Prepaid Products (except Vodafone Mini Caps and Vodafone Prepaid Caps) provide you with a type of credit called "Flexible Credit". Flexible Credit can be used to purchase any of the Products listed in the table titled "Payable from Vodafone Prepaid Credit" in section 11 below. The \$2 and \$4 Vodafone Mini Caps come with Mini Cap Credit. Details on what Mini Cap Credit can be used to purchase can also be found in the table titled "Payable from Vodafone Prepaid Credit" in section 11 below.
- (g) Vodafone Prepaid Caps come with Cap Credit. Details on what Cap Credit can be used to purchase can also be found in the table titled "Payable from Vodafone Prepaid Credit" in section 11 below
- (h) Some Vodafone Prepaid Products may also provide you with additional types of credit that may be used to purchase Products. Some types of such additional credit may only be used to purchase certain Products. Types of additional credit, and the Products that such additional credit can be used to purchase, are specified for each Vodafone Prepaid Product in sections 3, 4, 5, 6, 7, 8, 9 and, 10 below.
- (i) Credit may be expressed in any manner, including as a monetary value or as a quantity of a specified Product.
- (j) Unless otherwise stated, the section of the Terms titled "Vodafone Rates: What is payable from my Vodafone Prepaid Credit?" specifies which Products are available to be purchased from your credit and the rates for those Products.
- (k) All rates and charges are subject to change. Vodafone will comply with relevant regulations and industry codes with respect to such changes.

Voucher Expiry and Credit Expiry

- (a) One way of recharging your Vodafone Prepaid service is to purchase a Vodafone Prepaid recharge voucher at participating outlets. These vouchers have a voucher expiry period, which is the period of time you have to activate that voucher before it is no longer valid. Vodafone. Vodafone Prepaid recharge vouchers have a maximum voucher expiry period of 6 months'. Failure to activate a Vodafone Prepaid recharge voucher prior to the expiration of the applicable voucher expiry period will result in the value of the voucher being forfeited and it will not be refundable or exchangeable for another Product.
- (b) Once activated, some Vodafone Prepaid Products have a credit expiry period. Credit expiry periods are specified for each Vodafone Prepaid Product in sections 3, 4, 5, 6, 7, 8, 9 and 10 below.
- (c) Unless otherwise stated in the Terms, when the credit expiry period elapses or when the Vodafone Prepaid Product is recharged (whichever occurs first), any unused credit for that Product is forfeited, is not refundable, and cannot be carried over to any other Product.
- (d) Unless otherwise stated, if you change from a Vodafone Prepaid Product to any Vodafone "postpay" Product, any unused credit from your Vodafone Prepaid Product is forfeited, is not refundable, and cannot be carried over to your new Vodafone Product.

Auto Recharge

- (a) You may choose for your Vodafone Prepaid Product to be automatically recharged by payment using a registered Credit Card. This service is called "Auto Recharge".
- (b) You may nominate for this automatic recharge to happen:
 - i. On a specified date each month;
 - ii. When the main credit balance falls below a set nominated amount; or
 - iii. Every set number of days.
- (h) If you choose the Auto Recharge service, your credit card will be automatically charged when the nominated event in section (b) occurs.

- If applicable for your Vodafone Cap Recharge Product, unlimited voice and video Calls to personal mobiles and landlines in Australia can only be used when in Australia. Excludes premium and re-routed calls and cannot be used for commercial purposes or for resale purposes.

- (f) If you recharge on any Vodafone Prepaid Recharge Product (excluding a Vodafone Mini Cap Recharge Product but including, but not limited to, another Vodafone Cap Recharge Product) before the end of your Credit Expiry Period, all unused credits and allocations from your Vodafone Cap Recharge Product will be forfeited, will not be refundable and will not carry over to your new Vodafone Prepaid Recharge Product..
- (g) If you change from a 365 Day Recharge Product, or a TXT & Talk Recharge Product **(Original Recharge Product)** to a Vodafone Cap Recharge Product before the end of the Original Recharge Product's Credit Expiry Period, any unused Flexible Credit from your Original Recharge Product will be rolled over to your Vodafone Cap Recharge Product and will have the same Credit Expiry Period as your Original Recharge Product.
- (h) If you change from a Vodafone Pay As You Go Recharge Product or a TXT & Data Recharge Product **(Original Recharge Product)** to a Vodafone Cap Recharge Product before the end of the Original Recharge Product's Credit Expiry Period, any Flexible Credit and allocations will not transfer over to your Vodafone Cap Recharge Product, however, if you change back to your Original Recharge Product before the end of your Original Recharge Product's Credit Expiry Period, any unused Flexible Credit and allocations from your Original Recharge Product will be available again and will have the same Credit Expiry Period as your Original Recharge Product. However, after 7 November 2011, if your Original Recharge Product is a TXT & Data Recharge Product, you will no longer be able to recharge on the TXT & Data Recharge Product again and any unused Flexible Credit and allocations from that Original Recharge Product are forfeited, are not refundable and will not carry over to the next Vodafone Prepaid Product which you elect to purchase.
- (i) If you change from a Flexi Cap or Vodafone All-time Recharge Product to a Vodafone Cap Recharge Product before the end of the Credit Expiry Period, all unused credits and allocations are forfeited, are not refundable and will not carry over to your Vodafone Cap Recharge Product.
- (j) If you are on any Cap recharge at 24 September 2014, you can recharge on the \$70 Cap recharge and keep recharging with \$70 vouchers purchased prior to 24 September 2014. If you move onto another recharge product, you will not be able to move back to the \$70 Cap.
- (k) Until the earlier of either (a) the voucher expiry date or (b) 24 March 2015, \$70 vouchers can be redeemed against the \$70 Cap product by customers on any Cap as at 24 September 2014.
- (l) The Vodafone Cap Recharge Products are not to be used for commercial or resale purposes.

The following terms and conditions apply to you if you purchase a Vodafone Pay As You Go Recharge Product:

- (a) Vodafone to Vodafone Credit can only be used for standard voice calls made to other Vodafone mobiles in Australia.
- (b) If you exhaust your Vodafone to Vodafone Credit, additional calls to Vodafone mobiles in Australia will be paid for from your Flexible Credit.
- (c) Data can only be used in Australia, on Vodafone Networks. Data usage is charged in 512kB increments, with the first 512kB of usage in each data session zero rated. For example, if you use 700kB, you will be charged 1c (zero for the first 512kB, and 1c for the next 512kB block).
- (d) Data will be paid for from your Flexible Credit at Pay As You Go Mobile Internet Rates.
- (e) Where a recharge is made via one of the following channels, Free Flexible Credit will be applied. This Flexible Credit will be treated and subject to the same usage conditions and expiry period as per Flexible Credit

- (f) If you recharge your Vodafone Pay As You Go Recharge Product with another Vodafone Pay As You Go Recharge Product before the end of the Credit Expiry Period, unused Flexible Credit will be rolled over, provided you do not exceed the maximum balance of \$1,000.
- (g) If you change from a TXT & Talk Recharge Product, TXT & Data Recharge Product or 365 Day Recharge Product (**Original Recharge Product**) to a Vodafone Pay As You Go Recharge Product before the end of your Original Recharge Product's Credit Expiry Period, any unused Flexible Credit and allocations will not be rolled over, however, if you change back to your Original Recharge Product before the Original Recharge Product's Credit Expiry Period ends, any unused Flexible Credit and allocations (excluding any unused Vodafone to Vodafone minutes if your Original Recharge Product is a 365 Day Recharge Product) will be available and will have the same Credit Expiry Period as your Original Recharge Product.

- (a) Vodafone to Vodafone Talk minutes allow you to make calls to other Vodafone mobiles in Australia up to the duration included in your recharge. Vodafone to Vodafone Talk time is deducted in blocks of 1 minute, with a minimum call length of 1 minute.
- (b) If you exhaust your Vodafone to Vodafone Talk time, additional calls to Vodafone mobiles in Australia will be paid for from your Flexible Credit.
- (c) If you recharge your 365 Day Recharge Product with another 365 Day Recharge Product before the end of the Credit Expiry Period, unused Flexible Credit will be rolled over but any unused Vodafone to Vodafone Talk time balance will be immediately be forfeited, will not be refundable and will not carry over to your next Vodafone 365 Day Recharge Product.
- (d) The maximum Flexible Credit balance you may hold for the 365 Day Recharge Product is \$2,000.
- (e) If you change from a TXT & Talk Recharge Product to a 365 Day Recharge Product before the end of the Credit Expiry Period, any unused Flexible Credit from your TXT & Talk Recharge Product will be rolled over to your 365 Day Recharge Product, until the original Credit Expiry Period ends.
- (f) If you change from a Vodafone Pay As You Go Recharge Product or a TXT & Data Recharge Product (**Original Recharge Product**) to a 365 Day Recharge Product before the end of your Original Recharge Product's Credit Expiry Period, any unused Flexible Credit and entitlements will not be rolled over, however, if you change back to your Original Recharge Product before your Original Recharge Product's Credit Expiry Period ends, any previous unused Flexible Credit and allocations will be available again and will have the same Credit Expiry Period as your Original Recharge Product. However, after 7 November 2011, if your Original Recharge Product is a TXT & Data Recharge Product, you will no longer be able to recharge on a TXT & Data Recharge Product again and any

unused Flexible Credit and entitlements from that Original Recharge Product are forfeited, are not refundable and will not carry over to the next Vodafone Prepaid Product which you elect to purchase.

- (g) If you change from a Flexi Cap Recharge Product, or a Vodafone Cap Recharge Product or a Vodafone All-time Recharge Product (**Original Recharge Product**) to a 365 Day Recharge Product, your Flexible Credit and allocations will not be rolled over and will not be available if you change back to your Original Recharge Product.
- (h) If you are on any 365 Day recharge at 24 September 2014, you can recharge on the \$150 365 Day recharge and keep recharging with vouchers purchased prior to 24 September 2014. If you move onto another recharge product, you will not be able to move back to the \$150 365 Day recharge.
- (i) Until the earlier of either (a) the voucher expiry date or (b) 24 March 2015, \$150 vouchers can be redeemed against the \$150 365 Day recharge by customers on any 365 Day recharge as at 24 September 2014.

6. Vodafone All-time Recharge

- b) you do not recharge on a different Vodafone Prepaid Product.

The rest of your calling time will be free. If you start a call after 7pm Monday to Friday and your call continues past 7am Monday to Friday, you will be charged the standard call rate for your calling time after 7am.
- (d) Unlimited text to personal mobiles in Australia can only be used when in Australia. Excludes premium and re-routed TXT and cannot be used for commercial purposes or for resale purposes.
- (e) Your Data allowance can only be used in Australia, on Vodafone Networks. Data usage is charged in 1 kB increments. If you exhaust your Data allowance, additional data will be paid for from your Flexible Credit at Pay As You Go Mobile Internet Rates.
- (f) If you recharge on any Vodafone Prepaid Recharge Product (including, but not limited to, another Vodafone All-Time Recharge Product) before the end of your Credit Expiry Period, all unused credits and allocations from your Vodafone All-Time Recharge Product will be forfeited, will not be refundable and will not carry over to your new Vodafone Prepaid Recharge Product.
- (g) If you change from a Flexi Cap or Vodafone Cap Recharge Product to a Vodafone All-time Recharge Product before the end of the Credit Expiry Period, all unused credits and allocations are forfeited, are not refundable and will not carry over to your Vodafone All-time Recharge Product.
- (h) If you change from a TXT & Data Recharge Product, Vodafone Pay As You Go Recharge Product, 365 Day Recharge Product or TXT & Talk Recharge Product (**Original Recharge Product**) to a Vodafone All-time Recharge Product before the end of your Original Recharge Product's Credit Expiry Period, any unused Flexible Credit and allocations will not transfer over to your Vodafone All-time Product, however, if you change back to your Original Recharge Product before the end of the Original Recharge Product's Credit Expiry Period, unused Flexible Credit and allocations (excluding any unused Vodafone to Vodafone minutes if your Original Recharge Product is a 365 Day Recharge Product) from your Original Recharge Product will be available again and will have the same Credit Expiry Period as your Original Recharge Product. However, after 7 November 2011, if your Original Recharge Product is a TXT & Data Recharge Product, you will no longer be able to recharge on a TXT & Data Recharge Product again and any unused Flexible Credit and allocations from that Original Recharge Product are forfeited, are not refundable and will not carry over to the next Vodafone Prepaid Product which you elect to purchase.
- (i) The Vodafone All-time Recharge Product is not to be used for commercial or resale purposes.

7. Flexi Cap Recharge
